## - CARLOS DOMINGUES DUPLEX -

BOARD MEMBER BROWNE: Our next item of business is Carlos Domingues Duplex, Project No. 2012-04. This is a site plan being presented by Taconic Engineering.

MR. HINES: They've got a new name, Cliff.

BOARD MEMBER BROWNE: Oh, Talcott Engineering.

MR. RAAB: Jim Raab.

At our last meeting two months, about a month and a half ago, we had a number of items we needed to clean up. We needed to get an updated survey which was provided by Richard Surace so that we could get a fix on where the culvert is on the property. We have provided Danny Bloom's office with a description, which he is preparing an offer of dedication to the Town. Mark Taylor had said that they may or they may not accept it, but we need to go to the Town Board and find out what they want.

The catch basin was put in by the town so there's no problem with that. I spoke to Mike and Darryl Benedict about that and he has no issues with the easement at all. If we need something in writing from Darryl I'll be glad to get it.

We cleaned up the grading and got the proper separations from the drainage to the septic system. And of course, I just said we cleaned up the property boundary survey.

## - CARLOS DOMINGUES DUPLEX -

And we have, just for Bryant's information, we had submitted the stamped. Rich uses a raised stamp. So I submitted it to John. Everybody else got a copy of that plan.

That's pretty much it.

MR. HINES: Just we have some revisions.

The septic system general notes need to state that an as-built survey will be provided to the Town of Newburgh Code Enforcement Department prior to issuance of a CO.

The septic system is designed using a proprietary system that requires the same gradation chart be shown on the detail sheet. I think there was reference to the chart, but it just wasn't there.

And then we're suggesting that, although you said dedication, I think we're just looking for an easement for the stormwater.

MR. RAAB: Yes. Well, we offered dedication of the easement.

MR. HINES: That needs to be sent to the Town Board and coordinated through Jim Osbourne's office or the highway superintendent, whichever is the appropriate agency there.

# 1 - CARLOS DOMINGUES DUPLEX -2 Otherwise, our previous comments have been addressed. 3 CHAIRMAN EWASUTYN: Bryant Cocks, planning consultant. 4 MR. COCKS: Our previous comments were also addressed. 5 They did provide the adjacent property owners in the site 6 survey sheet. 7 My only comment was just to add the color and material 8 types to the architectural drawings for the Building 9 Department. Beyond that, other than the standard ARB conditions, the only required -- I'm sorry. Two. One is our standard condition on outdoor fixtures and amenities: You can't build anything in the site plan, not shown on the approved plans And there two new dwelling units, as I understand, in this duplex, therefore, a parkland fee in the amount of \$4,000.
